There will be a **Pre-Bid Meeting held at 10:00 AM on Tuesday, March 6, 2018**. The meeting will be held at McCarthy & Smith, Inc. office located at 24317 Indoplex Circle, Farmington Hills, MI 48335. All bidders are encouraged to attend.

All bids shall include 2 copies (1 original, 1 copy) of the Proposal Pricing Form (Section 00300), Proposal Execution Form (Section 00400), and the Iran Economics Sanctions Act Affidavit (Section 00421).

All bids must be accompanied by a Bid Security, in either the form of a bid bond or certified bank check, in the amount of five (5) percent of the amount of the bid, payable to White Lake Township Library, as a guarantee that if the proposal is accepted, [the Library is secured from loss or damage by reason of the withdrawal of the bid or failure of the bidder to enter a contract for performance. Further,](#) the bidder will execute the contract and file the required bonds within ten (10) days after notice of award of contract.

If awarded a contract, the successful bidder may be required to furnish a Performance Bond and Labor and Material Payment Bond. The Board of Trustees reserves the right to accept or reject any or all bids; to award the bid in part or in total; to waive any informalities therein; or for any reason, to award the contract to other than the low bidder.
