Held at White Lake Township Library, Wednesday, November 19, 2025

Call to Order - The November 2025 meeting of the White Lake Township Library Board of Trustees was called to order by President Jennifer Schultz at 6:47 pm.

Pledge of Allegiance

Roll Call - President Jennifer Schultz, present; Vice President Eric Shotwell, present; Treasurer Gwendolyn Newton, present; Secretary Carie Francis, present; Trustees Becky Knapp, present; and Trustee William Lonsberry, present. Director April Stevenson and Assistant Director Amy Rosen were also in attendance.

Approval of the Agenda

William Lonsberry made a motion to approve the agenda, moving the presentations to time of arrival; Eric Shotwell seconded the motion. The motion carried (5 yes votes).

- Polling Location Request - Township Clerk Anthony Noble. Anthony Noble provided additional information regarding the possibility of the White Lake Township Library serving as a polling location.
- Millage Strategist - Dave Forsmark. Dave Forsmark provided information about his consulting services for the upcoming millage for the library.

Approval of the Minutes (2 Sets)

Eric Shotwell made a motion to approve the October minutes as presented; seconded by William Lonsberry. The motion carried (5 yes votes).

- Policy Committee - The report was presented by Eric Shotwell and placed on file. The next meeting will be December 2. Eric Shotwell made a motion to accept the 5E. Unattended Children policy as revised. Carie Francis seconded the motion. The motion carried (5 yes votes).

- Millage Discussion - The board discussed the possibility of hiring consultant Dave Forsmark. Gwendolyn Newton made a motion that the library millage for the 2026 primary states that we are asking the citizens of White Lake to renew the current .3603 mill and restore .0258 mills (2018 level). Eric Shotwell seconded the motion. The motion carried (5 yes votes).
